**Re:** June 14, 2018, Coordinating Council Advisory Committee Meeting Overview

This memo provides an overview of the Coordinating Council Advisory Committee (CCAC) meeting on Thursday, June 14, from 1:00-3:00 p.m. at ICJIA's office at 300 West Adams, Chicago, Suite 200. We look forward to your participation.

As the CCAC will have newly appointed committee members joining for the first time, we would like to give an overview of the scope of ICJIA's coordination work with local, state, and federal partners. To that end, we will have short overviews of our programs including Criminal Justice Coordinating Councils, Juvenile Justice Coordinating Councils, Family Violence Coordinating Councils, Adult Redeploy Illinois, JAG Partnership Focused Deterrence sites, and VAWA Multidisciplinary teams. Our hope is that representative of these programs on the CCAC briefly describe and answer questions about the purpose and scope of their initiatives and upcoming programming that may be of interest to the committee.

As discussed at our last meeting, ICJIA hosted "Data, Planning, and Impact: A Joint Adult Redeploy Illinois and Criminal Justice Coordinating Councils" in Bloomington this May. We leveraged the resources of ARI and CJCCs so that both groups would benefit from the chance to collaborate and learn from each other. To memorialize the summit, ICJIA staff are drafting a report summarizing summit activities, the feedback received, and how our takeaways will inform ARI and CJCC programming moving forward. At our June meeting, we will present early high-level insights from the summit that we intend to incorporate in the written report. In preparation, we ask you to consider the following draft recommendations for the report:

- ICJIA should develop strategies to sustain current CJCC partnerships and build relationships with additional counties. This includes:
  - Focusing on developing partnerships with colleges and universities to expand research and evaluation work with local jurisdictions
  - Incentivize local planning and coordination activities through ICJIA grantmaking
  - Use planning grants to create a sustainable funding structure for coordination e.g. last for terms of two-year or longer
  - Offer analysis of local criminal justice trends and issues to any county on request
